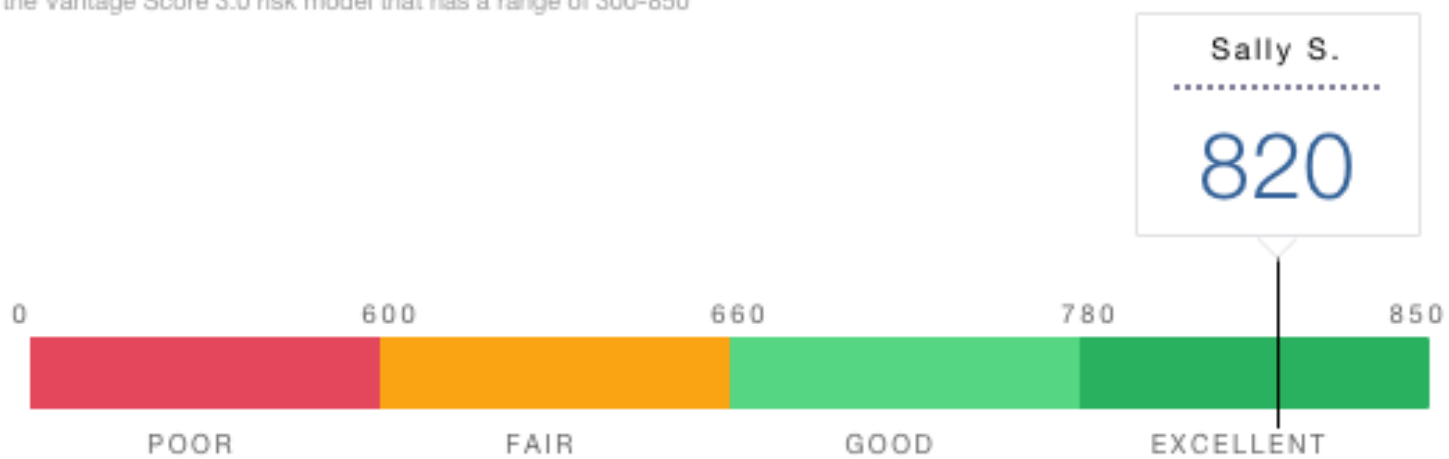

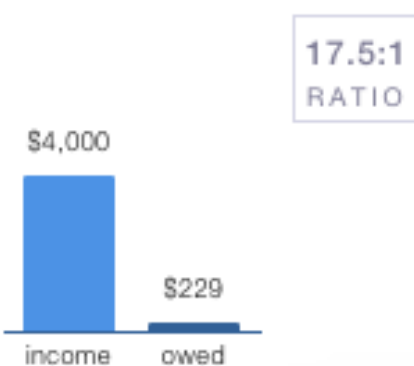

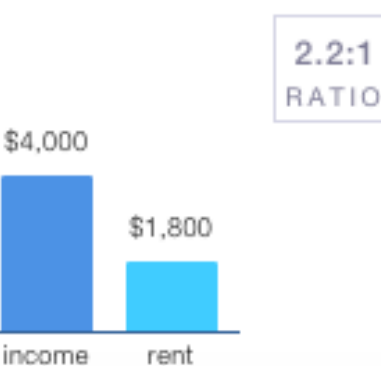

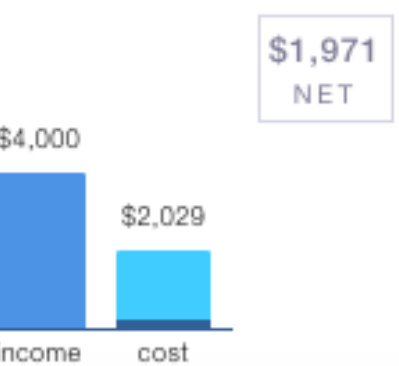
Income to Monthly Payments
